The India Pavilion, which is one of the largest pavilions at the Expo 2020 Dubai features an innovative kinetic façade made up of 600 individual colourful blocks. It is developed as a mosaic of rotating panels that depicts different themes as they rotate on their axis. It represents the theme of 'India on the move' and is a unique amalgam of the rich heritage and technological advances of the nation

India, which has actively led the fight for climate change and sustainability will also be using Expo's global platform to fortify its place in the world's fight against climate change.

IS DECISION FATIGUE THE TWIN OF "BURN OUT"

DURING THESE TIMES OF COVID?

oday we are going to talk about if - Decision Fatigue is the twin of Burn out? Before we start talking about this topic let's take a minute to reflect on what does a Burnout feel like? Most of us have gone through a burn out--it could be work induced or it could be induced by our emotions. Feeling numb about work, emotionally distancing ourselves, experiencing physical symptoms like headaches or stomach aches, feeling drained, feeling lethargic, lack of energy, difficulty concentrating and a total lack of creativity are a few of the outcomes. All of these symptoms start arising when we are exposed to prolonged work hours, unmanageable tasks, multiple decision making, unreasonable deadlines and working on tasks that are not particularly our expertise. **Burn out** can appear for something very different- now that

call this "Decision fatigue" Think about it - most of us will agree that although we are not engaging in anything that seems time bound or with deadlines, we are all in a constant state of decision making. We are preoccupied with life and death decisions of keeping our loved ones and family safe. We are working through decisions of the very basics of existence such as cooking a meal, cleaning house, doing laundry, etc. In addition, we are now dealing with a few more decisions that we have to be vigilant every day - Do I wear gloves, do I wear the mask, do I wash down the groceries when I bring it home, do I wipe down the bags that brought the groceries in, what about the cardboard boxes that was delivered by Amazon or do I wipe down the door bolts and handles, what about my shoes—do I leave it out or bring it in? These decisions are constantly on your mind-and they are 24 hrs 7 days a week and only continuing—day after

day! I hear that many do not find enough hours in a day to get things done contrary to what we think that at a time like this being at home, and having the time at our disposal we should be much more relaxed and at a better pace- but on the contrary – we feel overwhelmed, tired, lethargic and unable to concentrate .and go to bed and wake up feeling exhausted and tired. Do you see the parallel of a burn out here? Yes, very much, it is a constant psychological stress that puts immense mental strain considering our days in the past weeks has now become so monotonous with no clear sense of when and how this could get better and get back to normalcy within a certain time frame. . Therefore, days in the week has become today, yesterday, day before yesterday, tomorrow or day after tomorrow. We have lost count of the days and dates of the week. We are in a constant spiral of decision making which varies from borderline life or

death on one end of the spectrum and then basic survival decisions like breakfast, lunch and dinner on the other end. Everyone is trying hard to figure out how to exist in this new world. Trying to structure our day and priorities is becoming a challenging task especially when our home turf has become an "all in one" – home, office school, and last but not least our self isolation cell. No "me time" for quite some time!

This decision fatigue accompanied with the pressures that

we are put through to make informed, responsible, smart decisions and choices about our well being for ourselves, our families, and our community has in some ways lead to a pandemic specific Burnout. Alias Decision Fatigue Please remember experiencing some emotional exhaustion and anxiety is normal, but the problem is that many of our usual coping mechanisms have vanished - for instance taking a walk, going to the gym, meeting a friend and talking things out to name a few. Getting back to

some of our usual coping mechanisms might take time, so it is important for each one of us to find alternative ways to de-stress and de-fatigue – they have to be what works for you. It can be - sit in silence, do yoga, read a book, listen to music, paint/draw, or even binge on Netflix or potato crisps--whatever works for you . The focus is making sure that you stay the course and combat your decision fatigue with a few workable tips. The objective here today is to limit your number of daily decisions.

Let's see how we can do that -To start off with -

- **Make fewer decisions** learn to recognize the difference between urgency and emergency. Review how important it is to make a particular decision today. If it can wait, let it wait. Everything cannot be top priority for it to be done now!
- **Delegate decisions** Handover some of the decisions you usually make (work or home related) to another colleague or family member during this lockdown. Your plate might already be full. Ask for help and develop a team spirit—with your office colleagues and within your home.
- Make big decisions first thing in the morning this is the best time of the day, you are just waking up, you have much of the day ahead of you to still work with and therefore there is a sense of feeling that you can achieve much more. So get it done first thing and one less thing to worry about
- Limit your options and Keep the decisions simple you already have a lot to handle and your mind is constantly in a state of alert with decisions to make. For instance if you go into a grocery store to pick up a bottle of cooking oil, this might not be the time to go over all the different oils displayed on the shelves in the isle, to check where they are made and what the ingredients are instead pick one which would be most useful and economical for you. Your decision need to be that simple not more than few minutes to pick up that bottle of oil. Current situation warrants quick decisions.
- **Set deadlines to execute your decisions** this will give you a sense of progress and completion. All the more, it will also help you to visually cross out one decision off from your check list.
- **Go minimal** Drop the excess commitments out of your life. Take a look at your list. This is a very uncertain time in everyone's life and has its own level of stress. Having fewer tasks on your plate will lead to fewer decisions and this will help you to feel in control of the choices you make
- **Routine** Establishing daily routines will help you to minimize and simplify your choices. Having firm habits and a strict routine will help you to put certain decisions on auto pilot for example waking up time, meals, office work time, exercise/relaxation time, going to bed time, etc., instead of leaving it loose ended. These are major decisions and they need to be off your plate. Put them on autopilot. So, keep a routine it is a must.
- Aim for good enough than perfection— We often get trapped in our mind box that everything we do needs to be perfect you will agree that puts us in a lot of pressure to do things "right" because if not a wrong thing will ruin everything. It is ok if your meal is burnt or your child is glued on to the computer longer than agreed or your spouse did not get the dishes done as agreed. Take a deep breath; let it go as these are little things in the bigger picture. Focus on what you got accomplished and it might be lot more than you expected. Celebrate it and be kind to yourself. It is all about pushing through one day at a time now.

We marked this year's Teacher's Day by recognizing 75 teachers from Indian Curriculum schools in Dubai and Northern Emirates. These 75 teachers came from different educational backgrounds and have achieved various awards in

HAIR FOR HOPE INDIA

air for Hope India is a campaign to create awareness about hair donation, the brain child of Premi Mathew, a cancer survivor. In 2013 she officially launched Hair for hope india in India after inspiring a lot of Indians in UAE to donate hair from 2011. Hair for Hope India is the first national campaign to create awareness about hair donation in a country steeped in tradition, where the length of hair is a measure of a woman's beauty!. Awareness was zero and all cultural values were against it. Today hair for hope India is the most respected brand in the category and has held events in over 17 states in india and has an organic following of 41000 followers on facebook and 10,000 on instagram . Despite covid they held the First Global Cut A Thon live on zoom where 120 people from New York to Singapore cut their hair in June 2021! The event was inaugurated by bollywood star Mr Milind Soman at Lonavala who cut the first ponytail!. After hosting the first event 10 years ago and donating the first wig in India in 2013, the campaign now focuses on educating NGOs, Clubs, Churches, Schools and even MNCs to host events and convert it into wigs and give it directly to patients. Step by step assistance is provided free of cost to ensure that the hair really reaches the chemo patients. The hair donated is converted into wigs and given free of cost to cancer patients to give them to strength to fight the disease. For a lot of Indian women lose their confidence when they lose their hair and find it tough to face society with dignity. Today thousands of wigs have been

donated as NGOs around the country joined the movement. A unique contribution of the campaign is to provide a forum to connect 5 donors directly with a patient so that the donor knows exactly where the hair goes and can be rewarded with tears of joy as she personally gives the wig! It also averts the possibility of frauds misusing the cause . The campaign is run without any funds and staff and is manned by Premi who handles the social media, organises events and PR and correspondence. What is beautiful is that the campaign is run by students as young as 7 who organize events at their own schools at zero cost. A milestone in 2021 was when 26 Boys from over 20 schools in Dubai donated hair, a unique way of helping cancer patients. Aarunya a 7 year old also became the youngest to host a hair donation event.

The hair donated in UAE goes to Friends of Cancer Patients, an initiative by the Sheikha of Sharjah while the hair donated in India goes to cope with cancer and Amala cancer Centre. The Consul General of India, Dubai , H.E Vipul cut a ponytail and inaugurated a special hair donation/ breast cancer awareness event in 2020 and supported the movement.2021 was also no different as the Consul General of India H.E Aman Puri felicitated 20 boys who grew their hair to donate to cancer patients against all odds.C onsul litender Singh Negi cut the hair of threeyear-old Taksh Jain who is probably the youngest boy in the world to donate 16"donated his hair along with the other boys. 12" of clean, dry, hair, tied as per instructions at www.protectyourmom.asia could be the best gift for a cancer patient!

he Indian High School Dubai was one of the largest centres allotted outside India to conduct the NEET 2021 in the Gulf countries. The National Testing Agency (NTA) through the Indian Consulate in UAE selected this school to carry out the highly demanding examination professionally. The Indian High School deputed over 430 school staff to administer this examination under the consul education Mr Ram Kumar as the City Coordinator and the Principal Abraham Manoharan, as the centre Superintendent .The NTA appointed the Consul Education Mr Ram Kumar Thangaraj as the city coordinator along with 3 vice

consuls Mr Ashish Dabas, Mr Ravi Remuka, Mr Sahil Aggarwal as the observers for this medical entrance exam. The consulate education provided extraordinary leadership and guidance to conduct this massive exam for 1853 students in this Dubai centre in a meticulous manner. The Indian High Group of Schools CEO Mr Punit Mk Vasu and the school management provided all the facilities of the school benevolently and kept open all the facilities for the smooth conduct of the exam. All the teachers of the Indian High School were well oriented on the overall conduct of the NEET 2021. The candidates appeared for the NEET exam were comfortable from

the entry to exit . Early arrivals were provided with refreshments from the school. Even on their exit students were offered with snacks box. Covid protocol were followed and social distancing maintained throughout the campus. Documentation, after the examination, were extensive and enormous with so many annexures. All the tasks were completed by the dedicated school team with the consulate officials. The sealed boxes were taken by airfreight and handed to the NTA on the same night in the city office. To our surprise the Dubai centre was the first centre to deposit the exam materials box to the NTA in Delhi.



LEGAL REFORMS IN THE PERSONAL STATUS AND CRIMINAL LAWS OF THE UAE

INTRODUCTION:

The year 2020 was a year of big legal reforms in the UAE. This was the year when the country had witnessed a paradigm shift from its traditional legal framework. While some reforms were aimed at enhancing the ease of doing business in the country, the others were planned to improve conditions of life, especially of the large expatriate population living and working in the UAE. The reforms introduced were in respect of laws regarding corporate, personal status and criminal matters.

REFORMS IN THE PERSONAL STATUS LAW:

For expatriates working and living with families in a foreign country, the application of inheritance and matrimonial laws hold special relevance. Often, due to contradicting provisions of laws in one's native country and in the country of one's residence, an expatriate is likely to experience problems in concluding transactions pertaining to inheritance. Likewise, problems may arise in respect of proving the validity of marriage and divorce as well.

In the UAE, the erstwhile position of laws regarding inheritance and divorce was set forth by the Federal Law No 28 of 2005 on Personal Status which

In matters of inheritance for a person dying intestate (i.e., without a will), the pre-reforms position was that Islamic Shari'a would apply by default. However, by FDL 29/2020, certain provisions of the Personal Status Law and the Civil Transactions Law, were amended.

Following the amendments, the general provisions in respect of inheritance is summarily described as follows:

· Matters pertaining to inheritance or "heritage" are to be governed by the laws applicable of the deceased person's native state at the time of his als and expatriates, alike. The Personal Status Law is based on the Islamic Shari'a. The Personal Status Law invariably applied to matters of succession or divorce, unless the parties involved made a specific request to the competent adjudicating court for application of their own personal laws. This led to several practical problems subsequently, whereby a divorce decree issued by a Court in the UAE may not be recognised in the country where the marriage was solemnised. because the personal laws of the parties to the marriage were not followed. has now changed by the Federal Decree Law No (29) of 2020 ("FDL 29/2020"). Pursuant to Article One thereof, unless the expatriates choose otherwise, the laws of their respective native countries shall apply for specific matters under the Personal Status Law. Additionally, by FDL 29/2020 certain provisions of the Federal Law No 5 of 1985 on the Issuance of the Civil Transactions Law were also amended. Consequently, the position of laws regarding inheritance, matrimonial matters and guardianship also witnessed a shift. The amended position is described here in

MARRIAGE:

summarily stated as follows:

· The validity of marriage shall be determined by the law of the country where the mar• Further, a marriage between two expatriates shall be deemed valid if the marriage was solemnized in accordance with the laws of the state where the marriage was solemnized.

However, it may be noted that marriage between a UAE national and an expatriate shall be subiect to the laws of the UAE.

ALIMONY / **MAINTENANCE:**

Following the amendments by FDL 29/2020, matters pertaining to "financial impacts" post-marriage like alimony or maintenance are also to be governed in accordance with the laws of the state where the marriage was solemnized.

DIVORCE, REPUDIATION AND SEPARATION:

Further, following the amendments by FDL 29/2020, matters like divorce, repudiation of marriage and separation between spouses are to be governed by the laws of the state where the marriage was solemnized.

GUARDIANSHIP, **CUSTODY, TUTELAGE:**

The objective matters related to guardianship, custody, tutelage, and other objective systems to protect persons lacking capacity are to be governed by the laws of the native state of the person whose protection is required.

NOTE FOR INDIANS IN THE UAE:

In view of the reforms, Indians living in the UAE, shall now invariably be subject to the personal laws of India, in so far as inheritance and matrimonial matters are concerned. However, it may

still be prudent and essential to check how judgements, orders and decrees of the UAE courts in respect of inheritance, succession and divorce would pass the enforceability test in India.

It is interesting to note that FDL 29/2020 has also created a provision for each Emirate to have its own "Non-UAE National Will" registry. While this is still under development, it may be noted that non-Muslim expatriates may approach the DIFC Wills Service Centre for registration of their wills in the UAE, for their assets around the world.

Indian expatriates in the UAE may also get their Wills attested by the Consulate General of India in Dubai. For further information, one may contact the Indian Embassy in Abu Dhabi or the Consulate General of India in Dubai

REFORMS IN CRIMINAL LAWS:

The UAE penal laws are largely provided in the Federal Law No 3 of 1987 on the Issuance of the Penal Law (the "Penal Law"). By the Federal Decree Law No (15) of 2020 ("FDL 15/2020") certain provisions of the Penal Law were amended, whereupon certain acts which were punishable by law before, have now either been decriminalised or the applicable penalties have been reduced.

COHABITATION WITHOUT MARRIAGE:

By Article 356 of the Penal Law (before FDL 15/2020) the act of sexual cohabitation without marriage used to be a punishable offence, even if the same was with mutual consent. This was called the offence of indecent assault. By FDL 15/2020, Article 356 has been amended entirely, and the provisions for indecent assault have been removed. Following this, unmarried couples may now live in the same accommodation, and cohabit without marriage.

ALCOHOL CONSUMPTION:


Traditionally, in the UAE, trade and consumption of alcoholic beverages has been highly regulated. By the FDL 15/2020, Article 313 of the Penal Law has been amended entirely and some leniency has been introduced inasmuch as consumption, possession or trading in alcoholic drinks is no longer a punishable offence so long as these acts are done in permitted places and as per applicable legislations.

However, in this context, the following points must also be noted

- Each Emirate is empowered to frame its own regulations for consumption, possession and dealing with and trading in alcoholic beverages. For instance, in Dubai, one would still require a license to legally purchase alcoholic beverages from authorised dealers.
- The minimum legal age for consumption of alcoholic drinks is 21 years.

CONCLUSION:

The UAE has traditionally been a progressive country, but deeply rooted in its culture, traditions, and values. It is also a country which has welcomed and continues to welcome people from around the world with open arms and has always been considerate of their happiness and well-being. The year 2020 reforms do exhibit a big legislative shift in the UAE, aimed at betterment of lives, and they demonstrate, how strongly the principles of tolerance and universal brotherhood are espoused in the UAE and amongst its leadership.



PRODUCTION LINKED INCENTIVE (PLI) SCHEME: A GAMECHANGER FOR INDIAN MANUFACTURING

ver the past few India's decades. growth economic trajectory has been grabbing attention and interest globally, not the least because of our strong economic fundamentals and our vast market size. Our economic growth rates in the recent past have also consistently been among the highest in the world, attracting some of the most prominent companies and investors to Indian shores. Increasing economic clout, in turn, has led to a broader global consensus about a larger role and place for India, both in geo-economic and geo-political terms. Our industrial policy has been an important pillar of our accelerating economic growth and with the most visible impact being witnessed in the remarkable journey of India's IT services sector, specifically in

the 21st century. However, there is wide agreement that domestic manufacturing has been somewhat unable to match the exponential growth of the services sector we have seen in the last decades. The advent of the coronavirus pandemic nearly two years ago hasn't helped and in fact, had brought most manufacturing and other economic activities to a grinding halt last year. But, like every crisis that comes with a so-called 'silver lining', this pandemic too, has given us all its fair share of lessons and learnings. Among the most prominent of these have been the risks of concentrating supply chains in a few geographies and exposing businesses to severe shocks in times of crises like this. A lot of countries such as India have an unprecedented opportunity to benefit from this global trend of seeking alternative sourcing des-



tinations by big businesses and to entrench themselves into the international supply chains.

Taking a cue from this learning, the Indian government launched last year what can aptly be termed as one of modern India's most economically impactful initiatives to bolster Indian manufacturing and our domestic industries in general. Since its launch last year, the 'Aatmanirbhar Bharat' campaign has witnessed a massive government push towards strengthening Indian industries through a slew of measures like incentives, subsidies and funding. Among the most significant of these measures was the approval by the country's Cabinet headed by Prime Minister Modi to extend the Production Linked Incentive (PLI) scheme.

The scheme, centred on incremental outputs, aims to widen the manufacturing and export capacities of Indian firms thereby, putting them at the heart of global supply chains. Based on an incentive-led encouragement model for domestic and foreign firms, these schemes aim to create technologically advanced and globally competitive national sectoral champions and expand the country's international trade. The main rationale behind extending the PLI across different sectors include developing the core competencies of Indian industries, encouraging innovation, enhancing job creation within the country, creating economies of scale through efficient processes and boosting their overall global presence. As mentioned repeatedly by our Prime Minister, an efficient, dynamic and resilient domestic manufacturing ecosystem is of utmost significance for India to

emerge as a global manufacturing hub. In the Union Budget 2021-22, our finance minister announced an outlay of INR 1.97 lakh crore (~USD 26 Billion) for the PLI schemes for 13 major sectors which have been shortlisted on the basis of their potential for revenue and employment generation. Covering employment generating sectors such as ESDM, automobiles, pharmaceuticals, telecommunications, textiles, food products, renewable energy, white goods and steel, the scheme envisions to provide an average 5 per cent of the production value as an incentive, implying that the minimum value of production in the country as a result of the PLI schemes stands to be around INR 3.92 lakh crore (~USD 500 Billion) in the next five years, as estimated by the NITI Aayog. This tremendous rise in produc-

This tremendous rise in production has the potential to create nearly 1.40 crore man-months'

worth of jobs directly from 2021-22, effectively translating to nearly doubling the existing Indian workforce across sectors. With the inclusion of the suppliers and vendors of the companies benefitting from this scheme, a total of 4.20 crore man-months of jobs are expected to be generated, according to data from the Indian Staffing Federation. PLI schemes will further help in reducing our import dependency by fulfilling domestic demand in the identified sectors. For instance, the PLI in telecom sector will aid in addressing over 80 per cent of import dependency in the telecom and wireless networking equipment segments. Similarly, the PLI for food processing will help facilitate an expansion of processing capacity to generate processed food output of about INR 33,494 crore (~USD 3.6 Billion).

In terms of visible. tangible outcomes, the most exemplary example of the PLI's success transforming manufacturlandscape of a sector can be from the electronics manufacturing domain, in which, within a few months of the scheme's launch, the 16 approved companies have produced goods over INR worth 35,000 crores (~USD 3.8 Billion), invested nearly INR 1,300 crores and are anticipated to generate around 22,000 jobs. Identically, a major

feat has also been seen in the Indian medical devices sector where 14 applications are approved with a committed investment of INR 873.93 crores (~USD 118 Mn). Setting the perfect precedent for replication by other sectors, the domestic pharmaindustry ceutical to witness a similar growth trajectory. For key starting materials/drug intermediaries and active pharmaceuingredients, approvals have been given to 16 applicants having committed a total investment INR 348.70 crores (~USD 40 Mn) and employment generation estimates

of about 3,042 overall jobs.

The government estimates the PLI scheme to yield employment creation from the next financial year onwards to be: 1.80 lakh job opportunities for manufacturing electronics/ technology products, one lakh jobs for pharmaceuticals drugs, 2.5 lakh jobs for the PLI-covered food segments, about four lakh direct and indirect livelihood opportunities in the white goods sector; and another 30,000 direct and 1.2 lakh indirect employment opportunities in the solar PV manufacturing ecosystem. The PLI scheme is widely anticipated to have a ripple effect on India's Micro, Small and Medium Enterprises (MSME) sector as such SME units, along with the anchor and supplier units will help in generating large-scale primary and secondary employment opportunities. Moreover, the specific product lines identified in each of the thirteen 'Champion' sectors are all based on

their high growth potential and ability to generate medium- to large-scale employment in the country within the next five to seven years.

The PLI schemes are a game-changing opportunity for Indian manufacturing to expand by leaps and bounds. Through their emphasis on higher value-addition, these schemes will aid in enhancing investments in innovation, research and development and upgradation of technologies developed and deployed by each of the identified 'Champion' sectors. Announced as a part of the larger flagship campaign of the Indian government to promote resilience in domestic industries and strengthen their capacities, the PLI scheme will be instrumental in ensuring that India becomes better integrated within the global value and supply chains. Thus, providing immense scope for Indian manufacturing to bolster and prosper in the years to come.







