GLOBAL NOTICE INVITING TENDER THROUGH E-PROCUREMENT



- 1.1 For and on behalf of the President of India, Commissioner, Directorate of Logistics, Customs & Central Excise, Dept. of Revenue, Ministry of Finance, Govt. of India, having its office at 4th Floor, 'A' Wing, Lok Nayak Bhawan, Khan Market, New Delhi - 110 511 invites e-tenders valid up to 180 days from the date of opening of tender, in two parts, namely, (1) Technical Bid and (2) Price Bid from tenderers who meet the qualification criteria laid down in Section VII for supply, installation and commissioning of **Three (03) units of Thermo Gravimetric Analyzer (TGA)** for use in analytical works of Laboratories of Customs & Central Excise, Government of India. The tender enquiry documents will be available on official website (www.cbce.gov.in and www.dolcbec.gov.in) and on www.eprocure.gov.in from 27.02.2018 to 13.04.2018. The tenders can be submitted online up to 1300 hrs. on 13.04.2018. The tenders will be opened online at 1500 hrs. on 17.04.2018 at Directorate of Logistics, 4th Floor, 'A' Wing, Lok Nayak Bhawan, Khan Market, New Delhi 110 511.
- 1.2 Details of the goods and services required, specifications, eligibility and qualifications to bid and instructions on how to bid and other details are available in the Tender Document which can be downloaded from www.eprocure.gov.in, www.dolcbec.gov.in or www.cbce.gov.in from 27.02.2018 to 13.04.2018. Last date of receiving clarification on tender is 15.03.2018 upto 1500 Hrs. The pre-bid conference will be held on 22.03.2018 at 1430 hrs. at the address mentioned in paragraph 1.4 below.
- 1.3 Interested tenderers may download the tender enquiry documents (TED) and submit their tenders online at Central Public Procurement Portal website: <https://eprocure.gov.in/eprocure/app>.
- 1.4 Earnest Money Deposit (EMD) of 3,60,000/- (Rupees Three Lakh Sixty Thousand Only) in the form of Bank Guarantee from a Scheduled Commercial bank (as per the Form-3 attached with the Tender) and a non-refundable Tender fee of Rs. 5,000/- (Rupees five thousand only) in the form of account payee demand draft / bankers cheque, drawn on a scheduled commercial bank in India, in favour of "Pay and Accounts Officer, O/o the Principal Chief Controller of Accounts, Central Board of Excise & Customs" payable at New Delhi, must reach at the address given below by 10.04.2018 at 1500 hrs. Tenderers, however, have to attach scanned copies of EMD & Tender fee along with the Technical bid of their e-tender.
