# PROCEDURE FOR SEEKING ASSISTANCE FOR REPATRIATION OF MORTAL REMAIN

#### 1. Death of Indian National Where Employer / Sponsor is Available

In the case of death of an employee, it is the responsibility of the employer/sponsor of the deceased to send mortal remain to his home country. As per Article 15 (3), Federal Decree Law No. (33) of 2021 of UAE 'the employer shall bear all the costs of preparing and transporting the corpse of the deceased worker to his home country or place of residence, if the family so requests'.

#### 2. Financial Assistance under Indian Community Welfare Fund (ICWF)

In some cases, the Consulate provides assistance through its panel of community associations under ICWF for repatriation of mortal remain **strictly on means tested basis** in accordance with the Government of India guidelines where the deceased does not have any employer/sponsor or insurance policy does not cover the cost of repatriation of mortal remain and the family is unable to meet the expenditure. The financial aid includes cost of death certificate, embalming, coffin, local ambulance and airfare to transport mortal remain to the airport nearest to the place of destination in India. Community associations undertake the completion of formalities related to the procedure across Emirates **without any service fee** in case of financial assistance being provided under ICWF. Following list of documents are required for applying for the assistance to repatriate mortal remain under ICWF:

- (i) Notarized letter from next of kin of the deceased mentioning reasons why the assistance is required;
  - (ii) QR Coded Income certificate from State government (issued by Tehsildar or above level Officer);
- (iii) Bank Statement of the deceased / next of kin of the deceased for the last 06 months; &
- (iv) All related documents related to death registration including visa copy and employer letter, if applicable.
