Among the 192 participating nations, India surely has made its mark since the inauguration of the Expo in October.

The India pavilion at Expo 2020 Dubai was inaugurated by Shri Piyush Goyal, Minister of Commerce & Industry, Consumer Affairs, Food & Public Distribution and Textiles, Government of India on 1st October 2021. The participants ranging from business and government delegates to enthusiastic visitors, who witnessed India's cultural diversity, ancient treasures, achievements, and cutting-edge technologies first-hand. From age-old yoga to India's foray into space, the pavilion brought to life a vibrant and ambitious India.

The India Pavilion, which is one of the largest pavilions at the Expo 2020 Dubai, features a kinetic facade made up of 600 individual colourful blocks. It is developed as a mosaic of rotating panels that depict different themes as they rotate on their axis. It represents the theme of 'India on the move' and is a unique amalgam of the rich heritage and technological advances of the nation. The highly dynamic India pavilion regularly changes focus along with the themes of the Expo. From states to corporates to sectors, it showcases a modern, robust

India, high on technology while simultaneously exhibiting the beauty of Indian art, culture and cuisine.

To celebrate 75 years of India's independence, 75 stories have been identified for 26 weeks and every evening, the façade turns into a vibrant show with sound, light, and projections. Every day, thousands of visitors come to the India Pavilion and get to experience India's enormous cultural diversity, heritage and the numerous opportunities presented by the country. The Pavilion has been built beautifully to ensure that the world comprehends India's





journey from being a land of monuments and forts to a nation that is now at par with the global contemporary architecture. ### **DISABILITY ETIQUETTE -ENCOURAGING RESPECT FOR ALL**

s per the United Nations, 1 billion people, or around 15% of the world's population, live with disabilities. Disability Etiquette is a set of guidelines that allow us to have meaningful interactions which promote inclusion. The first step towards adopting these guidelines is to always show respect,

and recognize that a person with a disability is a person like anyone else. Instead of just focusing on the disability, we must appreciate and emphasize what they can do. In fact, in the UAE people with disabilities are called the People of Determination (POD), in recognition of their strong will and the hard work with which they overcome the various obstacles they face. Like with any other person, when you speak with a Person of Determination speak to them directly and not just to their caregiver. Also when you offer to help them, ensure to listen to their response, and follow their directions. The following are a few guidelines that are important to remember while interacting with:

#### PERSONS USING MOBILITY DEVICES:

- A person's wheelchair is part of their body space and should betreated with respect. Don't hang or lean on it unless you have the person's permission.
- Speak directly to the person and if the conversation lasts more than a few minutes, sit down or kneel to get yourself on the same level as the person in the wheelchair.
- Structural barriers in public places create inconveniences for wheelchair users. You can help by advocating for wheelchair access.
- Do not use a parking spot designated for People of Determination.









### PERSONS WITH SPEECH DIFFICULTIES AND HEARING LOSS:

- Give your whole and unhurried attention to the person who has difficulty speaking or hearing. Allow extra time, and keep your manner encouraging.
- Ask the person or their caregiver what is the best way to communicate. Use sign language if you and the person are both familiar with it.
- Look directly at the person and speak expressively, clearly and slowly, without exaggerating your lip movements or shouting. Also, move away from background noise.
- Many persons with hearing loss read lips. Place yourself facing the light source when talking in order to provide a clear view of your face.
- If you have difficulty understanding, don't pretend that you do. Repeat as much as you do understand.
- The person's reaction will guide and enable you to continue the conversation.

### **COMMUNICATION WITH PERSONS WITH COGNITIVE/LANGUAGE IMPAIRMENTS:**





• Give extra time for the person to process what you are saying and to respond. Look for signs of stress and/or confusion.

### PERSONS WITH VISUAL IMPAIRMENT:

- When you enter a room, indicate who you are. Let the person know when you are leaving the room.
- When offering your assistance, do not grab a person's cane or arm as this can be very disorienting for the
- Remember that you'll need to communicate any written information orally.

India-UAE-Israel Economic Summit on 19 October 2021

## INDIA-UAE-ISRAEL ECONOMIC SUMMIT ON 19 OCTOBER 2021

onsulate General of India, Dubai in coordination with Consulate General of the State of Israel, Dubai hosted the India-UAE-Israel Economic Summit to bring key Israeli businesses to interact with their Indian and UAE counterparts in Dubai on 19th October 2021. Israel Export Institute and Bank Hapoalim, Israel were the event partners. Bank of Baroda and IBPC Dubai were the industry partners and sponsors for the event. Khaleej Times was the media partner for this event.

The objective was to deliberate and discuss ways and means to optimize trilateral opportu-

nity for trade and investment. The Summit was attended by 250 delegates including business leaders, Govt officials and experts from the sectors of agri and food, healthcare, IT and start-ups from Israel, India and the UAE. The discussions at the Summit centered around the possibilities of joint projects in clean energy, infrastructure, and agri-tech along with the ways to capitalise on the opportunities in healthcare and medical sector. The speakers at the General Session were Mr. Ilan Sztulman, Ambassador of Israel to Dubai, Dr Aman Puri, Consul-General of India to Dubai, Mr. Adiv Baruch, Chairman of the Israel Export

Institute, Mr. Ahmad Haddad, COO, JAFZA, Mr. Suresh Kumar, Chairman, Indian Business and Professional Council Dubai, Professor Leonardo Leiderman, Chief Economic Advisor, Bank Hapoalim, Professor of Economics and Business, Tel Aviv University, and Visiting Professor, Abu Dhabi School of Management (ADSM), Mr. Mohammed Al Marzougi, Director (Mep and Projects and Developmentt), EMAAR and Dr. Ron Tomer, Chairman, Presidency of Employers and Businesses; President, Manufacturers Association of Israel; CEO, Unipharm Ltd., Israel.

discussions were on Healthcare; Agritech (comprising of Cleantech, Energy, Foodtech, Tourism, Watertech& Smart Cities) and Tech Collaboration opportunities. India has had comprehensive strategic relationship with Israel and was the first country with which UAE signed the comprehensive strategic partnership. Since the signing of the Abraham Accords, business engagement between UAE and Israel has grown exponentially. Indian businesses based out of UAE are key stakeholders, in the UAE - Israel two way trade and investment relationship which

drivers of this engagement. India is also Israel's third largest trading partner in Asia and seventh largest globally. Though bilateral trade is dominated mainly by diamonds and chemicals, recent years has witnessed an increase in trade in areas such as electronic machinery and high tech products; communications systems; medical equipment etc. India continues to be a 'focus' country for Israeli Government's increased trade efforts. Indian software companies notably TCS, Infosys, Tech Mahindra and Wipro are expanding their presence in Israel. Israeli companies too have invested in India in renewable energy, real estate, water technologies and are also setting up R&D centers and production units in India. During April 2000 - March 2021, Israel's FDI into India was reported at US\$ 224.76 million.In the backdrop of the Abraham accord and recent initiatives, the UAE-Israel-India business corridor has witnessed lot of interest in collaborative projects among them. In a first of its kind trilateral venture, an Israel-based company, Ecoppia is producing an innovative robotic solar cleaning technology in India for a landmark project in the UAE. The cornerstone of this project lies in Israel's R&D capability, India's manufacturing prowess and human resource along with the UAE's capital and

Talking about the importance of collaboration, **Dr. Puri said**, "Pandemic has made the whole world realize how inter-dependent the countries are when it comes to dealing with global challenges of this magnitude. We need to turn this crisis into an opportunity to collaborate and make the world order more resilient in handling any crisis."

Mr. Ilan Sztulman, Consul General of Israel to Dubai, termed the summit a window of opportunities to collaborate and do more business together. He said, "This forum is symbolic as it comes immediately after the signing of the important economic cooperation agreement between Israel, the United States, the United Arab Emirates and India on 'shared issues of concern in the region and globally'."

Mr. Suresh Kumar said, "Israel, India and UAE have very inherent and intense interest in technology and can come together and make innovation the cardinal principal of relationship."

**Dr. Ron Tomer** stated, "I feel that these three nations (India, UAE and Israel) can complement each other and create a win-win situation that will bring great business for all of us. Our free trade agreement (FTA) with India is underway and we are also now in discussions to sign the same with the UAE."

The Israel side also invited India for investments and further collaborations in various sectors.



Mr Ravi had already created a hattrick of three Golden Book of World Records in


Once everything found to perfection, the foundation shifted its focus on organizing this event on a global stage. The idea was

### MARRIAGE AND DIVORCE OF EXPATRIATES IN THE UAE

In the previous two editions of India Matters, the several legal reforms introduced at the end of 2020, on corporate laws, personal status and criminal laws in the UAE, were discussed. Following my article in the last edition, I would re-emphasize that, for expatriates living with families in

a foreign country, laws regarding matrimony and inheritance, among others, hold special relevance. Following legal reforms in the UAE on personal status laws, it may now be possible for expatriates in the UAE to seek the application of laws of their home country. However, there may be

some impediments to such application.

Here in after, I shall attempt to discuss in further details on the legal aspects of marriage and divorce of expatriates in the UAE, in the light of the new legal reforms

### **MARRIAGE OF EXPATRIATES:**

The key reforms in the personal status laws were introduced by the Federal Decree Law No (29) of 2020 ("FDL 29/2020"), by amending the following laws:

- 1. Federal Law No 28 of 2005 on Personal Status (the "PSL"); and
- 2. Federal Law No 5 of 1985 on the Issuance of the Civil Transactions Law (the "CTL"). On marriage, the notable changes are stated as follows.
- 1. By the FDL 29/2020, the provisions of the PSL are only

made applicable to expatriates in the UAE, unless any of them insists on implementing the law of their country.

- 2. Further, by the FDL 29/2020, certain amendments have been made to provisions of the CTL in respect of validity of marriages. The key changes are summarily stated as follows:
- The validity of marriage shall be determined by the law of the country where the marriage was solemnized.

 Further, a marriage between two expatriates shall be deemed valid if the marriage was solemnized in accordance with the laws of the state where the marriage was solemnized.

However, there are certain other influencing factors on the application of the laws of one's home jurisdiction. These are dealt with in detail at paragraph 6 (Other Influencing factors) here in after.

### MARRIAGES AT THE CONSULATE GENERAL OF INDIA, DUBAI:

It may be of interest for Indian expatriates to note that the Consulate General of India (CGI) at Dubai, solemnizes and registers marriages for couples where at least one person is an Indian national. Such marriages are registered under the Foreign Marriages Act, 1969 (of India). However, it

#### THE FIRST STEP:

This is the step to set an appointment and submission of preliminary documents. The list of documents to be submitted shall vary slightly when the marriage is between two Indian nationals and where any one of the parties is an Indian national. The full list of documents may be accessed at the webpage of CGI mentioned above. It must also be noted that as a matter of practice, the doc-

may be noted that such facilities are available only for non-Muslims, and such marriages where either bride or groom or both are Muslims are not solemnized at the CGI of Dubai.

The solemnization/ registration of marriages at the CGI is conducted through 6 (six) steps

uments issued in UAE are considered to be valid for 3 months from the date of issue and those issued outside UAE are considered to be valid for 6 months, if no validity is specified.

#### THE SECOND STEP:

Here all five persons (couple to marry, and three witnesses) are required to appear before Marriage Officer at the CGI, for signatures. All such signatories must which are more particularised at the website of the CGI-Dubai (url: https://www.cgidubai.gov.in/page/marriages/).

However, for ease of reference, the steps are summarily restated hereinafter.

appear with their original passports and photocopies thereof.

#### THE THIRD STEP:

This is the stage for publication of newspaper notifications by the couples. It should be ideally done in a local English Newspaper (in the UAE) as well as an English Newspaper in India. The advertisement should contain the full text provided by the Consulate.

#### THE FOURTH STEP:

Once the notification is published duly in the two newspapers, the original print of the newspapers (where the notification was published) must be submitted to the CGI. Subsequently, a date, at least 30 days after the date of last publication of the

### notice shall be assigned for solemnisation of marriage.

#### THE FIFTH STEP:

One day before solemnization of the marriage, original passports of the couple and witnesses are required to be presented to the Marriage Officer at the CGI.

### THE SIXTH STEP:

On the scheduled date the prospective couple, along with the three witnesses, need to come to the Consulate for solemnization/registration of the marriage. They should carry their original passport.

### **DIVORCE**:

As such, in the UAE, the PSL is chief legislation with respect to matters like marriage, divorce, custody, tutelage and guardianship. Following the amendments introduced by the FDL 29/2020, the PSL is supposed to apply by default to non-citizens "unless any of them insists on implementing the law of their country, without prejudice to the provisions of Articles (12) .... of the

Civil Transactions Law promulgated by Federal Law No. (5) of 1985" (Article 1 of the PSL). Following the above, one may refer Article 12 of the CTL which provides that all substantive conditions pertaining to the validity of a marriage shall be governed by the laws of the state where the marriage was solemnized. It reads as follows:

#### "Article 12

The provisions of Clause (1) of Article (12) have been replaced by virtue of Article 1 of Federal Decree-Law no. 30 dated 27/09/2020, to read as follows:

1- For the substantive conditions for the validity of marriage, the law of the country where the marriage was concluded shall be referred to.."

#### **APPLICATION OF LAWS:**

In plain sight it may seem to one that the amendments introduced by the FDL 29/2020 gives expatriates the leeway to freely seek the application of the laws of their citizenship in matters pertaining to marriage and divorce. However, it may not be entirely so, as there are some impediments to such application. These are described here in after.

#### **DESTINATION WEDDINGS:**

The language of the law at Article 12 of the CTL provides that for substantive matters like divorce, repudiation of marriage and separation between spouses are to be governed by the laws of the state where the marriage was solemnized. If one were to strictly go by these provisions of the CTL, then all matrimonial matters pertaining to a couple (who'd elected for destination wedding) are to be governed by the laws of the jurisdiction where the marriage was solemnised, say for example - Mauritius. This may in the long run not be desirable considering the difficulties one may encounter in obtaining suitable legal counselling on the applicable laws of Mauritius, from legal practitioners in Mauritius, if and when a need arises.

### APPLICATION OF FOREIGN LAWS:

Another noteworthy impediment is that of the application of foreign laws in the UAE courts. Primarily, a translated version of the relevant provisions of the foreign law must be presented to the competent court. Subsequently, the law must be simple and easy to interpret not subject to abrogation or amendments in the jurisdiction where it is in force. Combining these impediments with the difficulties of a third jurisdiction are likely to enhance the complexities involved.

### PLAUSIBLE SOLUTION:

Given the circumstances, one plausible solution for Indian expatriates living in the UAE would be to opt for registration of their

marriage under the Indian laws in India or at the concerned jurisdiction they choose to have their destination weddings. This essentially would be helpful for the expatriates to seek application of Indian laws, before adjudicating courts in the UAE.

### **CONCLUSION:**

The impediments apart, the reforms by FDL 29/2020 have largely clarified the position of law with respect to application of PSL for expatriates. However, it must be appreciated that the reforms are still relatively new, and it may be expected that the anomalies, if any, shall also be clarified in due course or even be dealt with on a case-by-case basis.



Birds are also very close to human being since ages and it has always been very inspirational to man's life since stone age to the modern era and from the Stone Age Rock Paintings, Cave Paintings, Mughal Paintings to modern era paintings birds were and are integral part.

Birds are found everywhere from Arctic to Antarctica in different sorts of climatic conditions, varied bio diversities & habitats. Birding not just sharpen our sense but it also brings us close to the nature. Nature education is very important. A travel enthusiast always likes to explore & understand the

local culture, to be with local communities and study their surroundings, eating / drinking habits, tracking of animals, birds from the sounds they make, marks on the pathways or scratches on the barks of the trees. It's a fantastic world of experiences. Birding is an activity which helps us to bring more close to the nature and local communities. A visit to a bird sanctuary to make memorable it advisable to carry a good pair of binoculars, an expert or a field guide, if possible go with a bird-watching group.

There are approx. 11,000 bird species around the world and more than 1300 species are found in India. Birding Tourism is a billion dollar industry across the globe. Millions of

international trips are taken every year for the main purpose of Birding and India has a huge potential due to its diverse biogeography of different terrains from Trans Himalaya to Desert, Western Ghats, Deccan Peninsula, Gangetic Plains, North-East region and Islands. India is home to approx. 91,000 species of mammals, birds, reptiles, amphibians and butterflies. Lot of efforts are being taken at different levels by the Government and Non-Government organisations to protect the species, environment and creating awareness. India, which hosts to numerous species of birds, ranging from the paradise flycatcher with its absurdly long tail feathers to the brilliantly plumed.

Himalayan monal pheasant, is a birdwatchers' paradise. One of the joys of a game drive is stopping in a quiet part of the forest and listening to the song of nature: the flirtatious call of the whistling thrush, a chorus of crickets; the creaking of a bamboo grove; whispering of leaves caressed by the wind; the buzzing of a cloud of bees escorting their queen to her new hive... A flying lizard floating by.

One of the finest birding escapades on the planet, the misty Bharatpur Bird Sanctuary or the Keoladeo National Park, shelters over 230 species of birds, with thousands of migratory birds visiting it during winters. Sight the painted stork colony buzzing with activity, feeding their young ones and nesting and breeding, get mesmerised watching the Indian darters fight in a flurry of feathers and water drops or watch the Sarus cranes (Grus antigone), the tallest flying birds in the world.

Lying on the outskirts of Mumbai, Maharashtra, the Karnala Bird Sanctuary, snuggled in the lap of the Western Ghats, is one of the best bird watching spots. For those seeking a more in-depth insight into the fascinating life of birds, the 6-kmlong Mortaka Trail is an amazing spot with its fascinating array of birds like peregrine and shikra and butterfly life. The Kutch **Great Indian Bustard Sanctuary** is among the best places where visitors can spot the bustard, one of the heaviest birds. Additionally, you can see black and grey francolins, quails, larks, shrikes, coursers, and plovers. During winters, a walk up to the north coast area of Jakhau will reveal large groups of flamingos, herons, egrets, sandpipers, and other birds that are usually found in salt reservoirs and creeks.

The mesmerising Vembanad Lake, the Kumarakom Bird Sanctuary, in Kerala, is the nesting site of many migratory birds, which flock here in large numbers from Siberia and the Himalayas. The best season to visit the sanctuary is between June and August as it is the breeding season of wetland birds like white ibis, herons, egrets, little cormorants, Indian darters and kingfishers. Some other not-to-be-missed avian breeds one can

spot are wood beetles, larks, flycatchers, parrots, teals, Siberian cranes, owls, water duck and waterfowls. An intriguing way to visit the sanctuary is on a boat trip that gives a closer look at the birds flocking around the water body.

The scenic and small island of Pathiramanal, floating on the backwaters of Kerala, is among the best spots to watch rare migratory birds. It boasts around 50 species of exotic and 91 types of endemic birds. Some of the common birds one can sight here include common teal, pintail ducks, cormorant, night heron, darter, Indian shag, whistling duck, and little cormorant and whiskered tern.

The largest river delta in the world, Majuli has a huge diversity of avifauna and one can spot short-toed snake eagles, purple sunbird, brown shrikes, red munias, white-backed vultures, greater adjutant storks, Pallas's fish eagles, chestnut-bittern large cormorants etc.

The Ranganathittu Bird Sanctuary in the state of Karnataka is a paradise for bird-lovers. If fortune favours, one can also sight birds that come from as far as Siberia to make their home here. The largest wintering area for migratory birds in India, the Chilika Lake Bird Sanctuary, in Odisha, is a treat for bird-lovers.
