PHARMA ROUNDTABLE:

A SPECIAL SESSION ON ENVIRONMENT

ndustry leaders at the Roundtable on 'India - Pharmacy of the World' deliberated how the pharma sector has been contributing significantly to India's economic growth, while highlighting India's contribution to the global pharmaceutical industry. A special video on the 73rd Republic Day celebrations in India was also showcased on the mas-




most critical of times, have been exemplary and will act as an inspiration to Indians around the world," added Shri Sudhir.

PHONE SCAMMING AND WAYS TO AVOID GETTING SCAMMED

Phone scamming is quite a rampant menace these days – the effects whereof (largely negative) are felt far and wide. Here the perpetrator uses the deceitful means of assuming a false name/

identity over telephonic calls to gain unjust benefits from his victims at the other end of the call. In this edition of India Matters, an attempt has been made to throw some light on this criminal act in terms of the applicable laws of the United Arab Emirates, the recourse one may avail, if victimised and the safeguards one may take to avoid getting scammed over a phone call.

NATURE OF THE CRIME, THE MODUS OPERANDI:

In phone scamming, the modus operandi or the method of operation (generally) is as follows:

The perpetrator calls up an up-

The perpetrator calls up an unsuspecting victim, assuming a false identity (e.g., a bank official, or representative of the phone services provider). Under

the garb of the false identity so taken, the perpetrator uses various means to either entice or scare the victim, into sharing valuable information pertaining to the victim's bank accounts, debit/credit cards. Using the same, the perpetrator is able to dissipate

sums of money from the victim's account. The moneys are usually moved to an overseas account, or otherwise used for online shopping at the expense of the victim. In the cyber law parlance, it is called 'phishing'.

THE LAW AGAINST PHONE SCAMMING:

Phone scamming or phishing attacks by phone qualify for the offence of DECEIT under the provisions of Federal Decree Law No 31 of 2021 regarding the UAE Penal Code. As in a normal case of deceit, there is a perpetrator and there is a victim, and the means normally used is a phone. That said, it may be noted that in the UAE the robust legal strategies for combating phone scams have developed over the years. In this country, there is a lot of importance accorded to an individual's right of privacy and the protection thereof. As a natural consequence thereof, there are strong laws and legal measures for protecting the privacy of individuals. In terms of legislations, new laws have been introduced and the erstwhile laws have been

amended to suitably identify the offence of phone scamming or phishing. At the core of it, phone scamming is an offence, punishable by the applicable laws of the UAE. Therefore, whenever a person is victimized by such offences, his or her counsel's primary duty is to report the matter to the competent Police/ law enforcement department or Public Prosecution (as the case may be). Notably, in the UAE, reporting methods have also witnessed positive development inasmuch as such matters may now be reported online at dedicated police department portals. In Emirate of Dubai, report of incidences of phone scamming may be filed online at eCrime portal of the Dubai Police, or by calling 901 and reporting the incident verbally and directly over the call. Notably, the number '901' applies to the Emirates of Sharjah and Ajman as well, and residents of the said Emirates may call up the number to report such incidences. Notably such channels may be used to report other forms of crimes perpetrated using electronic means.

In the Emirate of Abu Dhabi, one may file a report regarding phone scamming incidence via the Aman Services of the Abu Dhabi Police, or by calling the toll-free number 800-2626, or by sending an SMS at 2828 or sending an email at aman@adpolice. gov.ae. These channels in the emirate of Abu Dhabi, may also be used to report incidences of electronic crimes.

PATTERNS IN PHONE SCAMMING:

For phone scamming to be effective and successful, it is essential for the perpetrator to gain the trust of his victim. This can be effectively achieved by attacking the victim's psyche so

as to elicit strong emotional responses from the victim, like fear or sympathy which would drive the victim into believing whatever the scammer says and then parting with important personal

information or money or handing out any other benefit to the scammer per his/ her 'instructions'! Scammers usually need to take the support of a concocted story to support the alias they take, and it is very important for the story to be believable. And for the story to be believable, it is important that the victims are either given a promise of great benefits e.g., in the form of huge lottery winnings or otherwise seeking help in the name of charity. Following are some of the aliases, perpetrators use in cases of phone scamming.

- Fictitious lottery winnings promising huge winnings. In these cases, the scammers pose as officials from the telecom service provider or a well-known brand operating in the territory informing their victims that their phone number got selected out of a draw of lots and that the victim has won a substantial amount, pursuant thereto. Once the trust is built, scam-
- mers seek out the bank account details of the victim or credit card information (including cvv and the OTPs generated by the corresponding banking service provider).

- products in unreasonably low prices. Often times, scammers promise majorly desirable and popular products e.g., smartphones/ devices in unreasonably low prices to their victims. Sometimes, scammers also promise tourism related products and services like low cost or free holidays to scam their victims.
- Threats of bank accounts being suspended for non-completion of fictitious KYC or regulatory requirements. This is one of

- the more common aliases taken by scammers to dupe their victims. Here the perpetrator poses as a bank official and calls up the victim conveying that the victim's kyc information has not been updated and seeks out existing (valuable) information.
- Charity for fictitious patients/ victims of calamities etc. In this method, the scammers try to gain trust and sympathy of their victims using concocted of stories of young children being in need of urgent surgeries, or of people suffering as victims of natural calamities. More recently, such incidences heightened during the CoVID-19 pandemic.

WHAT ADDITIONAL PROTECTION MAY BE PROVIDED:

In such crimes, the perpetrators get two major advantages which allow them to pass themselves off as someone else, to their unsuspecting victims. The first of these advantages is anonymity and the second is that such crimes can be given effect using a very commonly available and used tool in the world today i.e., the smartphone. However, some additional steps may definitely

be taken to curb the menace of phone scamming. In most cases, the scammers are successful in deceiving their victims because they have access to valuable information of their victims, which leads the victims to believe the concoctions of the perpetrator. The perpetrator uses key personal information of the victim to gain his/ her trust. This largely happens because of the free flow

of personal data with individual mobile or landline numbers. Curbing or controlling the free flow of such information would largely help combat phone scamming. Phone number lists with owners' data become a potent tool for scamsters to gain victims' confidence and become successful in their acts.

WHAT ADDITIONAL PROTECTION MAY BE PROVIDED:

To avoid becoming a victim of phone scamming, one may take the following recourses:

- To avoid sharing any information pertaining to his bank accounts (account number, IBAN, net-banking user-id/password), credit/ debit cards (i.e., card number, cvv and/or issue/ expiry date
- etc), e-wallets (e.g., Apple Pay, Samsung Pay or G-Pay) over a telephonic call with anyone. Where OTPs are received, one must not share the same with anyone over a telephonic call.
- To ask counter questions to verify the true identity of the caller.
- To follow the news and to keep an eye for reports about scamming incidents in the locality.
- To be vigilant and alert in calls purporting to have been made from banks/ financial institutions/ charitable institutions/ entities in the lottery business.

CONCLUSION:

Thus said, it is very important for people to realise and understand that scamming exists and anyone can get targeted for the same. It is thus important to stay aware and be alert at all times, in one's deliberations online and over telephonic conversations.

Jammu & Kashmir inks 8 investment agreements with global investors at Expo 2020

A business delegation led by the Lieutenant Governor of J&K, Shri Manoj Sinha, pitched investment opportunities to the global investors during the UT of Jammu & Kashmir's participation. From the business point of view, J&K has the capability to provide opportunity to the industries to compete, correct and collaborate with readily available abundant resources. Archaic laws have been removed and more than 890 Central laws, which are the key drivers of socio-economic growth have been made applicable in the last two years."Elaborating on the potential of collaboration between India and the UAE, Dr. Ahmed Abdul Rahman AlBanna, A<mark>mbassador o</mark>f UAE Embassy said, "India is the s<mark>eco</mark>nd largest trading partner for the United Arab Emirates and UAE is the third largest trading partner for India after the United States of America and China. Our total Foreign Trade figures reached about USD 60 billion in 2019-2020. The Comprehensive Economic Partnership Agreement (CEPA) between the United Arab Emirates and India will be crucial in deepening the ties between India and UAE. 


